7. PRINCIPAL'S REPORT - Circulated and taken as read

- **7.1** Mr O'Grady paid tribute to Mr Colin O'Connell, a popular and long-standing member of our property team for nearly 40 years, who died recently. His funeral will be well attended by current and ex-staff of Rathkeale.
- **7.2** Mr O'Grady acknowledged the huge success of the Christmas Fete, run by the Friends of Rathkeale College. The hard work done last year by the committee meant the smooth running of the event this year.

7.3 Mr O'Grady spoke to the document providing details of the 1^{st} XV Rugby tour to South Africa in March 2025.

7.4 Clarification was sought by members of the board on the safety and security measures for this trip and provision of insurance. The tour company should provide more information once the numbers are confirmed, and deposits paid. It was agreed that the board would give approval for the planning of the trip to continue but would like to see further information before giving the final sign off.

7.5 Mr O'Grady read an email from the Rathkeale accountant to provide information to assist the Board ratifying the Statement of Budgeted Cashflow 31.12.2024 and the Statement of Budgeted Position 31.12.24. Both Statements remain unratified after discussions at two previous board meetings. There was further discussion around this, but the board's decision remains not to ratify these statements.

ACTION: The board requests that the Mr Broom and the school accountant meet with the auditors to raise their concerns around best practice, so they are not in the same position next year.

7.6 Mr O'Grady spoke to the Draft Budget 2025 v3 as circulated. There have been some minor changes made to the previous version, which results in a reduced forecast deficit of \$128,000.

ACTION: The board requests a forecast cash flow for the end of January 2025.
